- > Dr. Ramirez congratulated newly appointed High School Principal Mr. Pafk. He also thanked Mrs. Neureuter on her retirement and congratulated Mr. Dolce and Mrs. Szczesniak on their tenure appointments.
- Mr. Lilleck thanked the Board for their support of his contract extension.
- > Mr. Petrus shared that the audit committee met and reviewed the audit report.

- ➤ Donation from the Foundation for Academic Excellence for Eggert Elementary Mr. Petrus reviewed the donation of \$800 for the payment of Slyboots to perform at Eggert's International Night.
- ➤ Donation from the Middle School PTO for the 8th Grade Mr. Petrus reviewed the donations of pens and pencils for the 8th grade activity night.
- ➤ Donation from the Athletic Booster Club for the Softball and Baseball Program Mr. Petrus shared that the booster club would like to donation three pitching screens for the batting cages for the baseball and softball programs.
- ➤ **Declaration of iPads as Surplus and Approval of Sale of iPads to Employees** Mr. Petrus shared that the technology department has five iPads no longer used. Four employees want to purchase the iPads at fair market value.
- ➤ Creation of the David A. Brown Memorial Scholarship Mr. Petrus stated the high school would like to create an annual scholarship of \$500 in honor of David A. Brown. The criteria is outlined in the scholarship.
- ➤ Phase #1 Capital Project Contractor Bid Awards Mr. Lilleck shared the bid awards came in higher than projected last year but not as high as they had projector prior to the bids due to escalating costs in the market. The bids total \$11,424,640 for this phase of the project.
- ➤ First Read of Changes to Policy 7330 Searches and Interrogations of Students Dr. Krueger shared that the changes are being recommended to align with suggested changes to the Code of Conduct. The proposed changes allow a school administrator, who has reasonable suspicion, to use a handheld metal-detecting device (i.e. a "wand") during a search. The hope and anticipation are that this will help combat vaping and be an effective search tool for students who hide vaping devices on their person.
