### Safety & Security Project An investment in the safety and security of our schools

Facilities Committee members at Orchard Park Central School District have developed a \$12.2 million Safety & Security Project that will be proposed for a vote on November 13<sup>th</sup>. This safety and security project is the first of three in a 10 year long range cost-effective facilities plan that will focus on building facilities enhancements in all six school buildings.

The Safety and Security project will have little to no new impact on property taxes as Capital Reserve Funds will be used and existing debt will be paid off.

According to Jeff Petrus, the district's assistant superintendent for business, the Safety and Security Project will have little to no impact on property taxes as Capital Reserve Funds will be used and existing debt will be paid off. The scope of work in the Safety & Security Project was approved by the Board of Education on August 20<sup>th</sup>.

The long range project goals are focused on (1) prioritizing and addressing almost \$50 million in Building Condition Survey items, (2) soliciting and prioritizing administrative facilities needs requests to enhance student programs and building functions, and

(3) keeping the long term debt tax impact of the District relatively stable over the next 10 or more years.

Project priorities include providing a secured main entrance in all six educational buildings, as well as a secured secondary entrance at the middle and high schools. (*Continued on page 3*).

# Superintendent's Column

A syou know, one of our most important goals as a school district is to ensure that we are providing a safe learning environment for our students and staff on all of our district campuses. Over the past few years, we have been working very closely with the Orchard Park Police and a security consultant on several initiatives

to improve the safety and security of all of our school buildings. Some of the safety and security improvements include:

- Police-involved lockdown drills at every school building on a regular basis
- Training drills performed by Orchard Park Police in our buildings
- Front door monitors at every building, police-trained in situational awareness, conflict resolution and de-escalation techniques
- The addition of second shift front door monitors, to assure monitoring whenever the buildings are open
- Police-trained bus drivers on the topics of medical emergencies, threats and weapons
- Crisis response teams at the building and district level, trained annually
- Front door security and infrastructure improvements
- Single point of entry with buzzers and monitors
- A visitor ID management system which monitors a national sex offender database
- Extensive security cameras, with more cameras being added
- Regular communication with our school counselors regarding students that may be at risk

Effective in October, we have a School Resource Officer (SRO) at the Orchard Park High School. For many years, the Orchard Park Central School District has had a very positive rapport with the Orchard Park Police Department. This partnership is evident throughout the district, and the resource officer position will build on that relationship. We are thankful for the assistance of Senator Chris Jacobs who secured a grant of \$40,000 to help offset the cost in the 2018-19 budget for the SRO.

You may also have noticed some changes to the landscaping at some of our buildings. We have trimmed back hedges and removed trees to increase the visibility of

the exterior parking lots and entrances for building personnel. We have also placed boulders around our middle school in order to help secure larger school and community events.

The district will be using some of the Smart School Bond funds to add cameras and speakers to the exterior of our buildings. This will allow us to communicate with staff and students that may be outside of the building.

Thank you again for your continued support of our students, staff and the Orchard Park school community.

## Safety & Security Project Continued

All Orchard Park schools will be reconfigured to provide a security vestibule where visitors will enter and be screened prior to having access to the building.

"We took into consideration recommendations from the Orchard Park Police Department and a local security consultant to help us prioritize the safety and security upgrades we should make in our schools. The secured vestibules will still allow visitors to drop items off and conduct school business without having to actually enter the building, thus increasing security at the main doors," Superintendent Matthew McGarrity said.

The Safety & Security project will also include non-security related renovations, predominantly at the Middle School, but also at Windom Elementary and South Davis Elementary. These include replacing roofs with expired warranties and restoring masonry in select areas of the building exterior at both the Middle School and Windom. Their roofs date back to 1990 (WE), 1991 (MS), and 1999 (WE & MS) and have caused many issues with leaks in recent years. Additionally, aging rooftop units will be replaced at the same time so as to prevent the disruption of repairing it later and potentially compromising the new roof's integrity. South Davis Elementary will see several ADA compliance upgrades, including exterior and interior ramping, and a reconstructed nurse's office area and main office. In addition to the security and renovation enhancements at each school building, District Offices will get new furnaces and condensing units, which will replace the original units from the 15+ year old building.

If voters approve the project in November, the district anticipates that the plans and specs will be submitted to the New York State Education Department (NYSED) for approval in June 2019. There would then be an estimated 42 week review and approval process that will take until April 2020 to complete. The targeted project start date is expected to be in the summer of 2020.

"The New York State Education Department's current review process for architect and engineering submittals is approximately 38 to 40 weeks. We are estimating a 42 week approval process to be safe when creating a timeline. There may be an opportunity for a third party review, which may shorten the approval process by several weeks, however we will not know if we can expect that until we get closer to the project submittal to the state in June 2019," Petrus said.





Roof replacements will occur at the Middle School and Windom Elementary on the portions of roofing that have expired warranties. Both the Middle School and Windom Elementary have had the most roof issues with many leaks in recent years. In addition, the portions of roof that will be replaced will receive new rooftop units since they are also aging. This will prevent the disruption of repairing them later and potentially compromising the new roof's integrity. In the images below you can see the year in which each portion of roof was placed at the Middle School and Windom Elementary. At the Middle School, the 1991 and 1999 portions of roof will be replaced, and at Windom, the 1990 and 1999 portions will be replaced.

## Plan for Continued Maintenance of District Facilities

Over the past 10 years, the district has worked to maintain and improve our aging buildings and infrastructure. Past community supported project work was done in the most cost-effective manner. Future building repairs and improvements will be handled in the same way – having a cost-effective plan prioritizing repairs and improvements using the Building Condition Survey. The New York State Education Department requires that school districts conduct a Building Condition Survey at least every five

years. The Building Condition Survey is a summary of inspection work conducted by architects and engineers and is presented to the Superintendent and the Board of Education. This information helps the Superintendent and Board prioritize and plan for needed repairs and replacements.

In November of 2016, I was asked by the Superintendent and Board of Education to chair a Facilities Committee that was charged with developing a 10 year, long range facilities plan. The committee is made up of our District architects, construction managers, engineers, school board members, administrators, department heads, and community members, with additional consultation with department staff of impacted programs. The priorities of this committee center around the following:

*The Safety & Security Project is the first of three in a 10 year long range cost-effective facilities plan.*

(2) Solicit and prioritize administrative facilities needs and requests to enhance student programs and building functions

(3) Keeping the long term debt tax impact of the District rather stable over the next 10+ years

The Facilities Committee met monthly over the last two years to begin to develop this long range

facilities plan, and more specifically, this \$12.2 million safety and security project. In August 2018, the committee presented this recommended project to the Board of Education. The Board approved the plan for a public vote during their meeting in September 2018. Over the next 10 years, the draft plan of the committee includes three projects, with this \$12.2 million safety and security project being the first step. After the November 13, 2018 vote, we will reconvene the Facilities Committee to begin planning the next steps for capital improvements that tie in both the facilities and programmatic needs of the District and keep the long term debt tax impact of the District stable. We will continue to update the community as the Facilities Committee continues with this ongoing process.

## Orchard Park Central School District Comprehensive School Safety Efforts

The Orchard Park Central School District is committed to the safety and well-being of our students. Over the course of the past year, we have made enhancements to our schools and our resources to increase the

effectiveness of our comprehensive school safety plan. In partnership with the Orchard Park Police Department and safety specialists, we strive to provide safe and supportive learning environments for our students. Below are a few key improvements that have been completed, with additional enhancements on the horizon.

### Physical School Buildings

Enhancements with the past year:

- Exterior enhancements for security at Eggert Elementary to increase visibility;
- Exterior rock perimeter installed at Orchard Park Middle School to provide added safety for pedestrians;
- Parking Lot reconfiguration (OPMS bus loop, Eggert bus loop).

### Technology & Equipment

Enhancements with the past year:

- Enhancements to the electronic visitor management system, which screens all visitors entering our buildings;
- Upgraded communication systems (telephone and P.A. equipment) for more effective communication in an emergency;
- Additional technology equipment (i.e. additional cameras, emergency communication equipment, etc.) included in next phase of NYS Smart Schools Funding.

## **Comprehensive School Safety**

### Professional Development

Enhancements with the past year:

- Police-involved lockdown drills at schools;
- SWAT team training (after school hours) at OPHS & OPMS;
- Numerous trainings for personnel related to crisis prevention and intervention.

### Personnel

Enhancements with the past year:

- Additional social workers to support the mental wellbeing of our students, and to provide preventative support;
- School Resource Officer (October 2018).

## Mental Health Training

On Monday, September 24<sup>th</sup> Orchard Park Central School District teachers and School Related Professionals attended a suicide awareness training given by the district's pupil personnel services staff. This professional development was available for employees in all six of the district's educational buildings and it gave staff the opportunity to learn more about mental health awareness. The training focused on the importance of suicide prevention; characteristics of at-risk students; their critical but limited role; clarifying the building referral process; and identifying school and community resources.

### **OPHS** Teachers Attain Master Teacher Status

T he Orchard Park Central School District is proud to announce that in early October two Orchard Park High School teachers were selected as members of the New York State Master Teachers Program by Governor Andrew Cuomo. Math teacher Brian Dena and Industrial Arts teacher Joseph Bella are two of the 275 recipients chosen.

The 275 Master Teachers are dedicated professionals who teach science, technology, computer science, robotics, coding, engineering, and math courses across grades K-12 including Advanced Placement, honors, Regents and International Baccalaureate levels. All Master Teachers are active beyond their classrooms.

Mr. Brian Dena is in his 23<sup>rd</sup> year at the Orchard Park High School and is currently teaching Advanced Calculus, AP Calculus (BC) and Applied Mathematics. In addition to teaching at the high school, he serves as the advisor of math club along with colleague, Bret Norvilitis and has previously served as the District 6-12 math coordinator. He has been a cooperating teacher for student teachers and a mentor for current teachers.

"Mr. Dena has long distinguished himself as an educator of the highest quality. On behalf of his colleagues at the high school, I congratulate Brian on this tremendous recognition," said Mr. Jonathan Wolf, Orchard Park High School principal.

In addition to teaching in Orchard Park, Mr. Dena is an adjunct instructor for Medaille College where he teaches classes that include elementary mathematics for aspiring teachers.


Mr. Dena learned about the Master Teacher program from a colleague and was interested in providing his students with STEM related applications in class. He feels that calculus is the language spoken in many of the sciences, especially physics. By working closely with Orchard Park High School Physics teacher Mr. Greg Hylkema, he gains new insight into providing students with physics-related activities.

As a Master Teacher, Mr. Dena is looking forward to building relationships within the STEM community. He states, "I feel that after 23 years I have gotten closer to mastering my own subject matter, but have a lot of learning to do in others. This experience will enrich my own teaching and in the end, my student's learning."

He resides in Wheatfield with his wife Rebecca and two daughters Allison (16) and Katelyn (13).

Mr. Joseph Bella is in his first year of teaching at Orchard Park High School, his Alma mater. Prior to coming to Orchard Park High School, Mr. Bella taught in the Buffalo School District at the Charles Drew Science Magnet, the Antonia Pantoja School of Academic Excellence, and the Fredrick Law Olmsted School.

As a Master Teacher, Mr. Bella hopes to learn and grow as an educator through exposure to the program's numerous collaborative professional development opportunities. This will allow him to integrate more STEM topics into the classroom.

Mr. Bella said, "I am excited to work with the teachers in the Master Teacher program to learn and grow, and help contribute to the excellent educational community here in the Orchard Park district."

Mr. Wolf adds, "Congratulations to Mr. Bella on being named a NYS Master Teacher. I am so pleased that Joe has decided to return to his Alma mater and continue the tradition of excellence in our technology department."



## OPHS Senior Competes in PURE Insurance Championship at Pebble Beach

Orchard Park High School senior Ben Spitz has just returned from a once-ina-lifetime opportunity to compete for the pro-junior title at the 2018 PURE Insurance Championship Impacting The First Tee. Ben was selected to represent The First Tee of Western New York in this official PGA Tour Champions event, which took place from September 28-30 in Pebble Beach, California.

Ben was one of only 81 junior golfers from The First Tee chapters to be selected to play alongside 81 PGA TOUR Champions as well as amateurs. The First Tee is a nationally-recognized youth golf organization whose program introduces kids to the game of golf while teaching The First Tee Nine Core Values. Selection was based on playing ability and application of these Nine Core Values and life skills learned throughout their involvement with The First Tee.

Ben contributed many of his own birdies to his team score with PGA Champions Tour member Fran Quinn. If Fran made a bogey and Ben made a par or better, Ben's score counted for the team total. It worked both ways, so if Fran Quinn bogeyed and Ben didn't par the hole, they had to take a bogey for their team score. Finishing -10 through three days of play is an impressive score. Only 24 juniors made the cut to Sunday out of 81 juniors. The winning junior Pro/Am score was -16. At one point on Sunday, Ben was only four strokes off the leaders.

Based on Ben's performance, one wouldn't have known that he was ill and in the hospital the first day of the tournament. However he's learned that when he's faced with a challenge, he's capable of getting through it. Playing in this event has also taught him how important it is to be consistent and have confidence during the game.

As a 2018 Section VI Boys Golf Individual Champion, Ben is an accomplished junior golfer who plays on the Orchard Park Varsity Golf team. He also participates in the Western New York Junior PGA league in the summer, as well as other local and state tournaments. Orchard Park High School Golf Coach, Nate Leary speaks highly of Ben when he says, "He has been a pleasure to coach over the years. He has been coachable, respectful, and an amazing team leader. Ben will truly be missed after he graduates this year."

Ben has been playing golf since he was seven years old and credits his grandfather to introducing him to the sport and The First Tee of WNY for expanding his love for the game. He says that First Tee Master Coach Patty Jordan-Smith is his golf role model as she represents everything the program teaches and has had a notable LPGA golf career. Ben has plans to continue playing golf at the collegiate level.

What he loves most about golf are the social connections he makes with others and ripping a drive up the center of the fairway. Ben feels that what makes him so successful at the sport is his work ethic. He spends a lot of time practicing, including implementing aspects of the game that will lower his score the most.

Ben's advice to kids interested in playing golf? "Get involved in The First Tee program and open yourself up to fostering relationships with others. Also accept advice from people who have gone through it before, even when you think you have all the answers," he said.
